



## BRAZIL 2026

### Consultant Qualification Guidelines



*Consultants* who consistently grow their Personal Sales and Sponsorships will have the opportunity to enjoy a *Cruise in Brazil in 2026!*

### *Methodology*

- The qualification period lasts for 10 months: March through December 2025.
- The achievement of goals is accumulated over these months. If someone achieves their goal 7 times, meaning in 7 different months, then they have met 7 out of the 10 goals. These months do not need to be consecutive. To determine if the goal was met in a month, it is compared with your personal baseline.
- There are three prize levels based on the number of months in which you achieve your goals.

### *Who is eligible for the program?*

- If you are a Consultant at the end of February 2025, you enter the program.
- If you are a Consultant but have been a Leader in any of the six months prior to the start of the qualification, you enter the program with Leader goals.

How are months accumulated to achieve goals?

To meet the goal for each month, you must fulfill two requirements:

1. Incremental Personal Sales	2. Incremental Personal Sponsorships
<p>Increase your Personal Sales by \$100 per month compared to your baseline.</p> <p>Your baseline is calculated as the <i>average of your Personal Sales</i> from December 2024 to February 2025. Your first minimum goal is \$200.</p> <p><i>Important:</i> During the last 6 months of qualification (July to December 2025), you must be a <i>Pro Consultant</i> (earning 30% on your Personal Sales) for your goal to count.</p>	<p>Increase by 1 personal enrollment each month, who sells at least \$100</p> <p>At the end of the month, you must count how many of your personal enrollments sold at least \$100 and compare it with your baseline.</p> <p>Only the total number of personal enrollments with sales of at least \$100 matters – not when they joined.</p>

What do you Earn?

Prize “Cruise in Brazil” (7 out of 10 months)	Prize “Airfare Bonus” (9 out of 10 months)
<p>Achieve your goals in 7 months to earn a 4-night cruise, all meals and medical insurance included.</p>	<p>Achieve your goals in 9 months to receive a \$700 cash bonus for airfare.</p>
<p>Prize “Bonus for Personal Expenses on the Cruise”</p> <p>A \$150 voucher for on board expenses such as spa treatments, excursions, cruise shop purchases, or specialty dining.</p> <p>Two ways to earn this:</p> <ul style="list-style-type: none"><li>• Achieve 10/10 goals.</li><li>• Achieve 9 goals and promote to <i>Leader</i> by July 2025, maintaining Leader title through the entire qualification and post-qualification periods.</li></ul>	

## *Details and Conditions*

### *For all participants:*

- If you do not meet your goal in a specific month, the next month's goal remains the same. For example, if your goal in March was \$1,000 and you did not achieve it, that will remain your goal for April. Each time you achieve a goal, the next one is unlocked.
- If you exceed your goal in a given month, subsequent goals will not increase.
- Incremental goals from the base are always respected, gradually increasing from the baseline.
- The "Airfare Bonus" of \$700 will be reimbursed upon submission of a receipt for a flight ticket to São Paulo, Brazil. Tickets must be purchased by February 15, 2026, and the reimbursement will be processed upon receipt and maintenance of eligibility.
- Prizes are non-transferable. For example, if someone earns the "Cruise" prize but does not want or cannot travel, the prize will be forfeited.
- For both the "Cruise Prize" and the "Airfare Bonus," no additional expenses (transportation, meals, tickets, tours) beyond those specified will be covered. Participants must consider these aspects when planning their participation.
- There are many available options to travel from Guarulhos Airport (São Paulo) to the Port of Santos.

### *For Consultants:*

- Consultants promoted to Team Leaders will continue competing as Consultants.
- Incremental personally sponsored Consultants do not have to be the same person every month. They can be different individuals. For example, if in March you have 5 and in the following month one of them did not meet their sales goal, but you sponsored 2 new Consultants who did, that month counts.
- Post-qualification maintenance until the end of January 2026:
  - You must remain a Pro Consultant.
  - You must maintain at least 4 of your personally sponsored Consultants with orders.
  - If you earned the "Bonus for Personal Expenses on the Cruise" voucher by being promoted to Team Leader, you must maintain your Leader title until the end of January 2026.
  - Failure to meet these requirements in January 2026 will result in forfeiture of the prize.
